The total spent on private in-patient mental health beds broken down by provider for the financial years 2019/20, 2020/21, 2021/22, 2022/23 and 2023/24 For each of the providers in (1) please list the name of the hospital or clinic used.

Response

Please see the table below and note the following:

- The data only includes private Inpatient bed provision.
- BSMHFT only took responsibility from 21/22 (Part year).
- Providers names are as they are recorded within the Purchase Ledger and in some cases, this may be recorded as the individual hospital rather than the Supplier Group.
- Supplier Information is only held on direct transactions with the provider, i.e. on receipt of invoice / credit notes. This will skew dependent on year the payment is made.
- The Trust is unable to collate the year in which the transaction relates to without exhaustive measures of reviewing all invoices.
- The costs per supplier as per the table are when they are noted in the ledger, and not necessarily to the financial year they relate to. The data will be corrected /netted to the month / year end accrual, which isn't held at supplier level.
